- 1 You must complete at least three additional forms:
 - Form DV-110, Temporary Restraining Order (only items 1, 2 and 3)
 - Form DV-109, Notice of Court Hearing (only items 1 and 2)
 - Form CLETS-001, Confidential CLETS Information
 - If you are asking for child custody and visitation, you must complete form DV-105, Request for Child Custody and Visitation Orders and form DV-140, Child Custody and Visitation Order.
- Turn in your completed forms to the court. Find out when your forms will be ready for pick up.
- 3 Once you get your forms back from the court, have someone "serve" a copy of all forms on the person in 2. The sheriff or marshal can do this for free. Describe Abuse on Date: 7/4/2023

I was emotionally abused when Brittiny told me she would kill herself because I refuse to take her to a family members birthday party. She asked me to take her to the hospital. The doctors evaluated her and did a 51/50 and admitted her for 48 hours. After the 48 hours, Brittiny was released and came back to my mother's home.

Then, I was further emotionally abused and humiliated when Brittiny called my mother, Cheryl Hernandez-Cole profanity names (explextives, "Bit..."). I felt demeaned as my mother is a nurse who attempted to help Brittiny.

Background: Brittiny has a history of medical posttraumatic stress disorder and anxiety from childhood trauma and she sees a therapist. After birth of Giannis, Brittiny was also diagnosed with post-partum depression and she is taking medication. History of medications include Lexipro, Zoloft, Atarax, Amlodipine. On 3/20/23, I was emotionally abused by Brittiny when she told me she did not want to live and it was too hard after I discovered alcohol in a glass that she was drinking while pregnant. I took her to Stanford hospital.

The doctors admitted her and gave her an evaluation and confirmed she was drinking. I had to take off work for 2-days because I was afraid Brittiny would hurt herself and the baby.



August 6, 2023

Brittiny told me that she would be going to the Kaiser pharmacy and getting food before 4pm. I was watching our son, Giannis, and finished cooking a chicken dinner and had sat to eat. Brittiny returned home some time before 6pm and said that she wanted to talk. She said that while she was out, she talked to her aunt and that she was advised to end the relationship. She then said that we needed to come up with a parental plan for Giannis, which I agreed to, until she put her friend, Anna, on the phone to listen to our conversation. I declined to talk with an outside party on the phone. Brittiny told me to get out. I had our son in my arms, so I got out of bed and walked around while she followed me and threatened to call the cops to get me out. I then walked with my son into the nursery and called 911 myself to let them know about the situation. Brittiny followed me and touched my arm trying to grab Giannis. When I refused, I walked away and she grabbed my arm. She then blocked the front door from me leaving. I walked back into the kitchen area to feed Giannis a bottle. She charged at us and snatched the bottle right out of his mouth. When I asked her what she was doing, she mocked me. She then went to my shoes in the closet and threw them out of their cabinets onto the ground. She then charged at me again and shoved me with both hands into the refrigerator. I shielded Giannis so that my shoulder slammed and he wouldn't feel any contact. Brittiny and Anna (on speakerphone) mocked me for asking her to stop putting her hands on me and charging at Giannis and I. She then charged at me one more time and said she was going to punch me. Her friend then told her to run out of the apartment and say that I was physically assaulting her, so when she went out the door, I went out of the door and told neighbors she was putting her hands on me with my son in my hands. The neighbor in unit #110 agreed to wait in the hall at the door to maintain peace. Brittiny kept her distance from Giannis & I and shortly after, police arrived. I explained to them that I was assaulted and I don't feel that my son or myself were safe around Brittiny, but because there was no visual or audio evidence, it was my word against her's because she was accusing me of assaulting her, which I did not do. The police told me that Brittiny claimed that I only stayed in the apartment as a guest a couple nights during the week, but officers found that to be questionable after looking through the apartment and seeing that my belongings were all throughout the unit. CPS arrived and I explained to them that there is a history of negligent care, abusive behavior and that I just wanted to make sure that my son was properly taken care of in my custody, as I have been his primary caregiver on a day to day basis since his birth. After a 4-5 hour wait, I was put in a position where I needed to vacate the premises and leave Giannis in Brittiny's care after both of us requested emergency protective orders against each other in place through 5pm on Friday, August 11, 2023. I felt emotionally and verbally abused when Brittiny snatched the bottle out of my son's mouth as I fed him, told the police that I hit her when I did not touch her, told the police that I wasn't our son's primary

caregiver, told the police that I didn't live in the residence, when the police handed me an EPO order and I continued to be emotionally abused about my son in Brittiny's care. The case number is #R23-08-0125. Below are the photos from the dates listed:

August 4, 2023

Brittiny and I planned a phone call with my mom, Cheryl Hernandez-Cole, to discuss guidelines for how we were going to parent our son, Giannis, together moving forward. Instead, Brittiny lashed out at my mom for situations from the past, raised her parenting into question and brought up my estranged father. My mom then hung up to avoid further conflict, which infuriated Brittiny even more. Brittiny then looked at me while I was holding our son, Giannis, and said "See how your mom acts?!" She then added her friend, Anna, to the phone call. I told Brittiny it was because she brought my father up. I felt emotionally abused when Brittiny got very close to both Giannis's face and my face, grinded her teeth and said, "I did not do that!" and shrieked while storming out of the room. I felt scared for my baby's life and my life.

July 19, 2023

The day started off great. Today was mine and Brittiny's 1-yr anniversary. I started Giannis off with his usual morning routine of bottle feeding, diaper changing, clothes changing burping and educational video. During this time, I presented Brittiny with a card, balloon, gift and told her that I loved her. Brittiny headed out to Kaiser for therapy right before 10:30am. Sometime around 2pm, she contacted me about a conversation that she had with my mother, Cheryl Hernandez-Cole, in regards to visiting with our son, Giannis. She was upset that my mom wanted to take Giannis to my grandparents' home in Livermore without us, stating that we needed to be present. I told her that I would talk about it with her when she returned home. When Brittiny returned, she called her friend, Anna, to remain on the phone during our conversation. When I told her that I wasn't going to engage with a voice outside of our relationship and parenting involved, she said that we were going to be broken up until I learned to. "fight for our family." I replied "Ok." Brittiny went on a walk. When Brittiny returned, she wanted to talk about what the plan was. I reminded her that she said we were no longer together, and she said I had 48 hours to vacate the apartment. I agreed and even offered to stay in the nursery room. This upset her, and she changed her mind and told me that I had to vacate the apartment by the end of the night. I told her that wouldn't be an issue. This upset Brittiny even more, and she grabbed my arm while I was holding Giannis. I asked her, "Please, let go of my arm." She grabbed one more time before letting go, at which point I got out of bed with our son and went into the nursery. She threatened to call the police if I took Giannis. She once again got on the phone with her friend, Anna, and they began creating theories about what was occurring. Brittiny then gave me until 7:30pm to leave. She then left the apartment. Because she had threatened to call the police before leaving, and had stated several times that she would up and leave with our son without giving me any knowledge since finding out that she was pregnant on October 21, 2022, I called 911 and told them what was occurring and that I had no issue leaving, just as long as I could take our son because I'm his primary caregiver in the household. The officers arrived and agreed that I could be escorted out with our son. When Brittiny came back into the apartment, she was angry and attempted to stop me from leaving. The police officers told her to stop, and then she got belligerent with them. I was then escorted to the parking garage where I left for my grandparents' home in Livermore. I was physically abused when Brittiny grabbed my arm in a manner that I did not approve of. I was emotionally abused by Brittiny when she used profanities at me and attempted to throw me out of our

residence. The incident report is #2307190195 by Officer Erick Chavez and Officer Captain Sears.

June 20-July 6, 2023

We were supposed to leave on June 21, 2023, to visit my mom, Cheryl Hernandez-Cole, in Southern California to celebrate my 34th birthday (June 23), 4th of July and just relax overall. Because of a triggering interaction with her sisters on June 19, 2023 that included drinking. Brittiny had anxiety attacks that lasted from June 20-26, causing her to remain in bed, which put the tasks of watching our son, Giannis, taking care of Brittiny and all of the household activities by myself. I eventually decided to pack everybody up into my car on June 26, 2023 so that we could finally head down. While in Moreno Valley, CA, Brittiny was admitted to Kaiser ER on 3 separate occasions (June 29, June 30 and July 4) with various ailments, one of which was diagnosed as a "51/50 Watch" by Kaiser specialists due to threatening to harm herself/suicide. On July 2, Brittiny started an argument with my mom and I over one of my family member's upcoming birthday party. This argument lasted several days. She was drinking during this time. Brittiny threatened to fight my mom. After being released from Kaiser, two separate police reports were made at the residence, the latter for Brittiny again, stating that she wanted to harm herself. Brittiny said that she wanted to leave multiple times, and I told her that she could go, but that she couldn't take Giannis, as she was still recovering from previous hospital visits and was having suicidal thoughts. Finally on July 6, Brittiny calmed down and was remorseful for her actions. From June 28-July 2, my cousin, his wife, his son and son's friend were at the house as well. I felt verbally and emotionally abused by Brittiny by the way that she used profanities towards my mother and I and threatened my mother's physical well being. I felt demeaned as my mother is a nurse who attempted to help Brittiny. Below are the photos from the dates listed:








June 5, 2023

My first day of paternity leave. Brittiny continued to bring alcohol into the apartment, even after I asked her to stop, so that it wouldn't interfere with her medication intake. Below are the photos from the dates listed:





June 2, 2023

This was my final day of work before starting my 12-week paternity leave.

May 19, 2023

I was emotionally abused when Brittiny led me to believe that she was seeing her doctors, taking her medications, taking care of our infant son, Giannis, while I went back to work for 5 days. During this time, I discovered multiple empty bottles of alcohol and knew I had to take paternity leave as quickly as possible. I was afraid for my son's life, safety, health and welfare. I contacted a social worker while at his 2-week appointment. They contacted CPS. I took Giannis to our family home. Later, my grandfather and I went to pick-up clothes and diapers for Giannis. Brittiny said that she wanted to harm herself. I encouraged her to go to the hospital. She refused to go. I felt emotionally abused by Brittiny when she over consumed alcohol while taking care of our son, Giannis, and said that she didn't want to live any more. Below are the photos from the dates listed:





May 8, 2023

Brittiny was complaining of pain in her abdomen, so we returned to the ER to get her checked back in for evaluation. My mother, Cheryl Hernandez-Cole, watched our son, Giannis Cole, at our apartment while we settled in, then she dropped him off to stay with us in the room over the next few days. Brittiny was released mid-week with medication and home in time for Mother's Day.

May 5, 2023

Brittiny gave birth to our son, Giannis Prince James Cole, at 6:38pm at Kaiser Redwood City.

April 5-6, 2023 (35 weeks pregnant)


Brittiny contacted both my mother, Cheryl Hernandez-Cole, and my sister, Cherie Cole, via text message while I was at work, stating that we were going to be guarded in who saw our child or not. I was unable to leave my post at work to stop the communication from occurring. I didn't agree with the information being sent out and told her in a phone call on my break. She got mad at me and told me that she felt like disappearing and needed space from me. When I returned to the apartment after work, she was already gone and wouldn't tell me where she was. Feeling distraught, I went to sleep and was awakened to a phone call where she shared where she was staying (I couldn't remember where due to waking up). I asked her to return and she refused. She called again about an hour later, and I made the comment that she makes things difficult and that it causes me to feel forms of depression and that there's times that I don't want to be here, as in the apartment. She then misquoted my words, called my grandparents and told them that I was suicidal. I then went for a drive to talk with both my mom and my aunt, Nicole Beamish. Brittiny then called to tell me that she was kicked out of her room and blamed me for calling the police on her, even though I had no idea what she was referring to, as I didn't remember where she was stationed. When I returned home, she was already back in the apartment. The next day, April 6, I went with my mom to visit my great-grandparents' gravesite. Brittiny kept calling my phone and continued to state that I wasn't standing up for our new family. I finally returned back to the apartment and she was groggy and sleepy. It was unconfirmed whether she drank. I felt emotionally abused by Brittiny when she sent unpleasant text messages to my family during work hours, left our apartment without telling me her whereabouts-knowing that she was clinically diagnosed by medical specialists as a high risk pregnancy-around 4-5 weeks before her delivery date, as I feared for the safety of my unborn child, contacted my grandparents with false information, and verbally told me I wasn't a good family man while I was paying my respects to my dead relatives.

March 17-20, 2023 (32 weeks pregnant)

On Friday 3/17, Brittiny and I planned to open gifts from our baby shower in our apartment after I returned from work. My family planned to attend. I was informed by my mother, Cheryl Hernandez-Cole, that there was a possibility that some of my family members could be late, which I informed Brittiny of during my lunch hour. Brittiny then sent me texts about how my family ruins our plans. I assured her that that wasn't the case. As I was driving home, Brittiny called me and put me on a 3-way call with my mother and began shouting expletives towards us that nobody cared about her and that she was done with the family. She blamed my brother, Dominique Cole, and threatened to fight him. Saturday 3/18, she continued arguing with me and eventually told me to leave the apartment before she went to work. Not trying to cause her heart rate to rise and affect our baby, I agreed to leave. A few hours later, Brittiny's sister, Pebbles, called me and told me that she advised Brittiny that it wasn't in her best interest to be alone, as she was diagnosed as a high risk pregnancy with hyperemesis and on medication, so she

agreed that I could return to be by her side after she returned from work. I returned to the apartment that evening. On Sunday 3/19, Brittiny again started to argue with me. I noticed there was a scent of alcohol. I was not drinking and had not been drinking. I went into the closet and found a bottle of Ukrainian Heritage brand vodka. I asked her if she had been drinking the previous three days. She confirmed that she had been. I removed the bottle from the premises into the trash in the garage. The next day, Monday 3/20, I was getting ready for work when Brittiny said that she didn't feel good. When I walked by her side of the bed, I saw a glass that smelled like alcohol. I realized it was from a new bottle, but could not locate it. She then said that she hadn't eaten for the previous few days, so I called in from work and took her to Stanford Children's Hospital. Brittiny kept saying, "I don't want to be here any more, Jay. I can't do this any more." She told nurses and doctors that she had in fact been stress drinking. One diagnosis from this visit was dehydration. I felt emotionally abused when Brittiny used profanities against my family and I, threatened bodily harm against my brother, asked me to be removed from the apartment around 8 weeks before her delivery date, was drinking liquor & not eating while pregnant with my child, and saying that she wanted to harm herself, as I feared for the safety of my unborn child, knowing that she was clinically diagnosed by medical specialists as a high risk pregnancy. February 6, 2023 (26 weeks pregnant)

I came across 2 of Brittiny's medications spilled all over the bed. Brittiny has a habit of not properly closing her medication lids, nor putting the medications back in their designated areas. I became frustrated because I couldn't tell which medications needed to go into which bottle. I felt emotionally abused by Brittiny when she failed to secure her medication because it made

me scared for my child's safety thinking about what could happen if our child were to ever get ahold of these pills and ingest them. Below are the photos from the dates listed:



November 23, 2022 (estimated 15-16 weeks pregnant)

Brittiny was staying in a hotel in Concord. She had a travel nurse contract for John Muir Hospital in Walnut Creek. I felt emotionally abused by Brittiny when she called me and spoke in a demeaning tone towards me saying that she didn't understand why she was staying in a hotel instead of at my home.

October 21, 2022 (estimated 10-11 weeks pregnant)

On October 19, Brittiny and I ended our relationship. On October 21, Brittiny informed me that she was pregnant. I agreed to meet her at THE LOT City Center in San Ramon to discuss our plans of parenting. I felt verbally abused when Brittiny sent a text message stating, "You've shown me time and time again that you don't fuck with me," because I refused to allow her to come to my home. When I arrived, she was at the bar drinking and talking to an older couple. I told her I didn't like her drinking after learning she was pregnant. Brittiny then got belligerent and verbally abused me in front of the bar in the presence of strangers. I felt humiliated. While Brittiny was inebriated, she verbally attacked security guards in the parking garage by yelling expletives at them. Two officers were called in our direction to intervene. I felt emotionally

abused when Brittiny initiated a drunken altercation with security, parking officials and police officers because I feared for the safety of my unborn child while she was pregnant.

August 12-14, 2022

During this time, Brittiny was taking medication after a hospital visit at Kaiser in Fremont lasting from July 28-August 4, 2022. Brittiny verbally abused me while she was a guest at my residence at the family home in Milpitas. I returned home from work when Brittiny said that she learned of a friend dying by suicide. She had been drinking wine and was inebriated. While I was comforting her, she asked what I wanted for dinner. I told her I was intermittent fasting and done eating for the day, but I would pay for whatever meal she wanted to order through DoorDash. She asked me 4 more times within a 30 minute span. I said I wasn't going to eat. She then got angry, told me I didn't care about her, and shrieked, "Get the fuck out of here!" while in my bedroom. I was emotionally and verbally abused by Brittiny when she used profanity towards me while in the presence of her foster sister, Pebbles (the telephone was on speaker), because I refused to allow her to live in our family home. Below is a photo of her medications:



After all of these events, I am seeking emergency temporary custody over my son, Giannis Cole, so that I can find time to go after what I ultimately want, which is full legal custodial care. I am ok with Brittiny having supervised visits with our son, Giannis, until Brittiny can show she is competent to care for our son and do what is in Giannis' best interest in terms of health and physical welfare.
